## AMENDMENT TO ENVIRONMENTAL AUTHORISATION FOR KLIPHEUWEL WIND FARM

This notification serves to inform you of the amendment to the Environmental Authorisation (EA) issued on 28 March 2013 for Klipheuwel Wind Farm (12/12/20/1746/1/AM4), operated by Globeleq South Africa Management Services.

The amendment pertains to Change of Name of the Holder of the EA and Contact Details which was granted by the Department of Forestry, Fisheries, and the Environment (DFFE) in terms of the National Environmental Management Act (Act no.10 of 1998) (NEMA) and the Environmental Impact Assessment (EIA) Regulations, 2014 (Government Notice no. R982 of 4 December 2014) as amended.

Your attention is drawn to your right to lodge a formal appeal with the Minister of Environmental Affairs. You are referred to Chapter 2 of the NEMA National Appeal Regulations, published under Government Notice R993 in Government Gazette No. 38303 dated 8 December 2014 (National Appeal Regulations, 2014), which prescribes the appeal procedure to be followed. Should any person wish to appeal the decision, the appeal must be submitted to the appeal administrator (details provided below), with a copy of the appeal sent to the Applicant, any registered Interested and Affected Party, and any organ of state with an interest in the matter, within twenty (20) days from the date on which this notification of the decision was sent to the registered Interested and Affected Parties (appeal period ends 17 March 2025).
